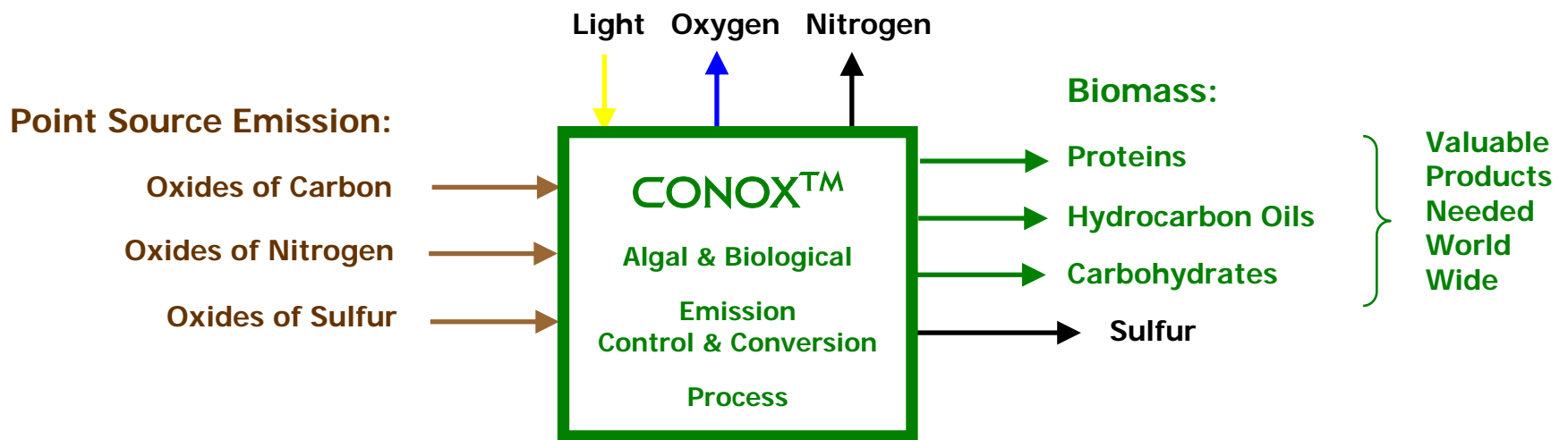
ClearValue has developed over 40 patents in the above technologies while having 11 patents issued.

CONOX™ Process



CONOX™ is a unique and patented design which converts point source emissions or other CO_x streams into products which are friendly to the environment, recyclable or salable.

CONOX™:

- Operates 24/7,
- Only produces biomass, oxygen, nitrogen and separated mercury as products,
- Handles products with available equipment,
- Is low on maintenance,
- Produces no toxic emissions, and
- Can be installed on new facilities or retrofitted to existing facilities.
- Comprises algal and biological systems which naturally convert point source emissions into valuable products.
- Comprises special design features which incorporate light into the biomass.
- Comprises special design features which minimize algal/biological reactor footprint. (A 2000MW Power Plant could fit its required CONOX™ Process within a city block.)
- Comprises algal and biological handling equipment.
- May generate power.
- Is a natural process.

CONOX™:

- Naturally produces crude oil.
- Naturally produces proteins.
- Naturally produces carbohydrates.
- Avoids abnormal handling of CO₂ in underground storage.
- Has a small process footprint.
- Is 90 to 95 % efficient; and with recycle, is 100% efficient.
- Is scalable from 1 to 200 Million cubic feet per day of point source emissions.
- Produces its own photons at night.
- Is naturally capable of hydrogen production.
- Is positive cash flow.
